PLUS ONE FLYERS, INC. is committed to protecting your privacy. This Statement of Privacy applies to PLUS ONE FLYERS, INC. web site and governs data collection and usage at all PLUS ONE FLYERS, INC. sites and services; it does not apply to other online or offline sites, products, or services. Collection of your Personal Information

Use of your Personal Information

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

PLUS ONE FLYERS, INC. does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

PLUS ONE FLYERS, INC. may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on PLUS ONE FLYERS, INC. or the site; (b) protect and defend the rights or property of PLUS ONE FLYERS, INC., including its web site; or (c) act under exigent circumstances to protect the personal safety of users of PLUS ONE FLYERS, INC. or the public.
